Could you share a little bit of your background?

I graduated with honors from Florida International University, receiving a Bachelor of Arts in Political Science with a Minor in History. I then earned my law degree from Villanova University School of Law.

In 2021, I joined Rivero Mestre. I was promoted to partner in 2023 and more recently was named managing partner. I handle complex business matters, international arbitration, and cross-border disputes.

Some of my notable cases include representing Dr. Craig Wright, self-proclaimed inventor of Bitcoin, in a \$600 billion trial regarding Bitcoin ownership, where we secured a verdict in his favor. I also represent several clients in Latin America with high-stake business disputes.

Alongside my legal practice, I am deeply involved in community service. I serve in leadership roles in various bar associations, including president-elect of the Cuban American Bar Association and president of CABA Pro Bono, which provides free legal services to the indigent community
